The DP is implementing a reform that reflects the realities of today's society. Over the coming years, families and children will receive targeted relief, while effective support will be provided to those who need it most.

1. A simple and fair tax system from 2028 onwards. With a single tax class, everyone will be treated equally, regardless of marital status, providing greater financial predictability in the event of changes in personal or family circumstances. A long transition phase will ensure that no one loses out.

2. Tax relief for families with young children. Through a tax allowance of €5,400 per year for each child under the age of three.

3. An increase in child benefit from 2027 onwards. An increase of €45 per month for children up to the age of 12, and €60 per month for children over 12.

4. Uniform and more affordable childcare costs for all forms of care. Through a reform of the childcare voucher system (chèque-service accueil), easing the financial burden on parents by €79 million.

In addition, the Democratic Party is committed to social justice and the fight against poverty in Luxembourg:

1. **Socially adjusted childcare fees.** Up to 29 hours of free childcare for parents earning up to three times the minimum wage.
2. **Targeted support for school-age children.** Up to €3,000 per year per child for low-income families.
3. **Combating old-age poverty.** Through a premium for older people on low incomes, amounting to up to €2,400 per year.
4. **Simplified and partly automated access to financial assistance for individuals and families in need,** based on harmonised criteria allowing several forms of aid to be granted simultaneously in a simpler, faster and, in some cases, automatic manner.

€900 million per year for a tax reform that respects all family models and provides stability. €250 million per year for higher child benefits and a family policy that offers stronger financial support to parents. €300 million per year to ensure reasonably priced childcare.

The DP stands for a **modern and fair society**, where life remains affordable and the future is open to everyone.
